G: Have you completed esafety training for parents?

HT: We are going to send a questionnaire and then deliver training dependent on their need. Esafety is a priority on the school plan this year.

G: The computing lead has sent an email to all staff asking for staff to complete an esafety question and answer session at the beginning of each computing lesson with children.

G: Early Career Teachers (ECT) were overwhelmingly positive about their experience at BFS but mentioned that they find it hard to mark the morning's work at lunchtime to be able to set the interventions for the same afternoon, I am aware this is operational but wanted to let you know? HT: The maths lead had asked teachers to have a look at lunch if they had time but we don't encourage people working through their lunch hour. The aim was to support children with that days maths issues.

9. Finance report

Distributed prior to the meeting and taken as read: Finance report November 2021

a) Review of budget documentation

G: Thank you for the summary report. It is very helpful. £51,000 in red but we have a carry forward of £62,000?

SBO: The GAG, funding based on pupil numbers, is paid the following year from the October census. This means we have to estimate the children who will be on roll. Children left the school who we had not expected to leave in year and who had been projected to be in school when the budget was set. This was 13 pupils gross and resulted in a £51,000 short fall. However, we still have a carry forward of £262,396 which is £62,674 higher than expected. The reasons for the increase were explained in the finance report to governors. We will have the confirmed figures from the auditor in the next few days. G: Covid recovery premium, is that in addition?

SBO: That is a new payment for 2021-22. The Covid Catch up grant was paid in 2020-21.

b) Update from School Business Officer on energy usage (from matters arising)

G: The energy usage – the renewable energy usage is 0%?

SBO: We have 26 solar panels in the new build. We have a CIF bid being completed for the fire safety works and we are going to submit another bid for lighting etc.

G: If we can win a bid for a renewable energy source I will try and find match funding.

Governors agreed that it would be beneficial to have renewable energy sources in the school and that it would be beneficial for the Eco-council to support with the process.

G: Could we work with local organisations to start rewilding?

HT: Yes, we can speak to the staff involved and work with the Eco-council to move forward.

HT: Now that the curriculum is organised enhancements are the next stage. Building outdoor learning areas would be helpful for teachers. We do have an outdoor log circle but staff need to understand how to utilise the area effectively.

HT response: Most of this is covered in the SEF.

Peer on peer abuse: all staff have had training on KCSIE 2021 during the INSET day in September. In addition to this there was an additional Staff Meeting updating all staff about safeguarding. Peer on peer abuse was part of this. There have been regular reminders in the staff briefing. We had a whole school assembly last Monday about keeping safe. SLT have all completed additional online training about peer on peer abuse. All schools in the Trust have been asked to prepare an appendix on this to reflect their practise. Once it is agreed I will share it with governors.

We have Eco Council, our geography curriculum includes climate change. Over the coming term and moving forwards this focus will increase as it looks like it is high on the agenda for the new Education Secretary!

Thank you to Gillian and Tanya for all the information prior to our meeting. A couple of questions from the reports: What is our capacity for nursery? How many families attend the coffee mornings? Thank you

Thank you Gillian for posting these reports well in advance to give us all plenty of time to read and comment.

To save time in the meeting, my comments/questions are as follows

- Behaviour report could we have numbers of pupils involved please as well as incidences? I am mindful that several incidences may refer to just one pupil?
- Attendance- I feel our figures are very acceptable in view of the past 20 months especially for our SEND (94%) and PPG (93.4%)- would you agree?
- Re SEND how is the new system of LButler and MConnell P/T working across the Trust working out for BF ? particularly with reference to the Staff Council comment about feeling there could be better information/communication regarding their SEND pupils ?
- Staff Council you have our total support when you say expectations MUST BE HIGH .Are staff absences still impacting so hard on PPA time? and good to see all the positivity re SLT/Headship/fellow staff members. Have you been able to talk to the office staff re comments that they are not as supportive as they might be ?Do you think this might be justified?
- CPD plan thanks for sharing .It is great to have such a very clear and detailed plan to drive quality teaching
- Pupil views re: safeguarding overall very positive, I know that you have since banned pupils from going behind the shed in the playground!
- SAFEGUARDING I note we now have one CLA and 3 previously CLA now adopted. Do they still receive additional funding/support ? And is Sarah W aware of them ?
- PASTORAL REPORT Many thanks to Alison for such a detailed and far reaching report on the vast number of initiatives they are carrying out. Particular mention to the COLLABORATION with other PST leads across the Trust and the Watford <u>S.Army</u> and Asda. Also working towards the MENTAL HEALTH KITEMARK award. Please ask Alison to keep us informed as to the progress.

Hi Lesly,

To answer a few of your queries:

Behaviour - I will add this and upload it; however, there aren't any 'repeat offenders' - most incidents have been by different children (and there may have been more than 1 child involved - as you will see on the report). There are 1 or 2 children with a few more behaviour incidents but these are recorded on CPOMS because they have SEND or child protection needs that require support, rather than sanctions due to 'poor behaviour', as such.

Attendance - really we would like higher attendance this year (aiming for 97%) Gillian and I will be speaking to the Herts attendance officer so can check if our figures are in line with others in Herts. I am aware that LHS and CTS have higher overall attendance; however they have not has as many covid cases this term. Our attendance is around 96% with covid cases not included, which is definitely worth noting.

School council - staff absences have only impacted on PPA in terms of the PPA time being changed, which is disruptive for children and teachers because they will have set things ready for cover and then it can often change. It hasn't impacted teachers actually receiving their time, thankfully.

Progress - I think it's because it's officially reported as being in top 20%; however, technically, we were in the top 3%.
